Sir/Madam,

In response to the above mentioned subject and reference in the above caption it is being informed that certain mandatory conditions which have been asked to fulfill, have been accomplished and all the deficiencies removed. Point wise details are as follow:

**Point(1)** - A ramp for CWSN has been started and constructed upto first floor. As per norms of CWSN guidelines, lift will be constructed in near future and for this, process has been already started. Till the permanent completion of lift ,construction of ramp as per CWSN norms, as stated above, has been started and work is complete upto first floor and will run up to the top floor.

Here, it is worth mentioning that we have enough space/rooms for one section of each class and it has been decided that one section comprising of general(normal) students and CWSN students will be formed and as stated above there will be enough space/rooms to conduct classes of one section of each class. In this connection it is also being pointed out that presently we do not have a single CWSN candidate on roll.

**Point(2)** - The deficiency pointed out in the general toilets have been noted and as per the directive by the honorable members of the earlier committee, separators between urinals have been created .

For CWSN boys and girls separate toilets have been constructed in all the floors.

**Point(3)** - In the light of SoPs issued by the board , labs, library and sports facilities have been upgraded and maintained.

On 3<sup>rd</sup> April 2023 we received a telephonic call from honorable member Mr. Ravinder Kumar (Coordinating Officer) wherein he asked for time required for completion of the required mandatory conditions. Here it is being mentioned that we have completed the required mandatory conditions and facts related to construction have been discussed in the above paragraph(s).

Therefore, it is being requested to do the needful and to kindly extend the affiliation. As per direction a fresh application for extension of affiliation will be sent.


